RESOLUTION OF THE BOARD OF TRUSTEES OF WEATHERFORD COLLEGE

At a lawfully called meeting on May 1, 2023, the Board of Trustees of Weatherford College (the "College") does hereby make the following resolution regarding the declaration of certain real property as surplus and authorizing the sale of such real property in accordance with section 11.154 of the Texas Education Code, as it applies to junior college districts, and Chapter 272 of the Texas Local Government Code:

WHEREAS, the College owns 294.906 acres, more or less, of unimproved real property located in Weatherford, Texas (the "Property"), which is more particularly described and depicted in Exhibit "A" attached hereto; and

WHEREAS, College has no future plans or need for the Property; and

WHEREAS, the Property is surplus property because the remaining real property owned by the College adequately provides for all of its known current and future real property needs; and

WHEREAS, it is in the College's best interest to sell the Property; and

NOW THEREFORE, BE IT RESOLVED, that the statements contained in the preamble of this Resolution are true and correct and adopted as findings of fact and operative provisions hereof, and

BE IT FURTHER RESOLVED, that the College's Board of Trustees orders and authorizes the sale of the Property, in accordance with section 11.154 of the Texas Education Code, as it applies to junior college districts, and Chapter 272 of the Texas Local Government Code, and orders and authorizes the College President or Board President to take any and all action to provide notice of the College's intent to sell the Property, and to prepare, execute, and file all documents necessary to carry out the conveyance of the Property, to the highest and best qualified bidder, including engaging the services of the College's legal counsel to help the College accomplish the purposes of this Resolution, subject to Board approval of the contract for sale of the Property, and reserved to the Board President to execute the deed, and all other documents necessary to convey title and transfer ownership of the Property; and

BE IT FURTHER RESOLVED, that in the event that the Property is surveyed and the legal description and acreage resulting from such survey differ from the descriptions of the Property set forth in Exhibit "A," the legal description contained in the survey shall be substituted as the legal description for the Property, for all purposes, including as a description of the real property to be conveyed;

BE IT FURTHER RESOLVED, that this Resolution shall be in effect from and after its passage on the date shown below; and

BE IT FURTHER RESOLVED, that the Board reserves the right to reject any and all bids received for the sale of the Property, regardless of the bid amount, if the Board determines in its sole discretion, that doing so is in the College's best interest.
